On page 4 and footnote 7 of that opposition brief, Oron erroneously stated 6 7 that Plaintiff claimed to have obtained an order "freezing Oron's assets (HK\$3,000,000) in Hong 8 Kong," and that "the \$3 million in Hong Kong is actually in Hong Kong dollars, not U.S. dollars and is approximately U.S.\$386,700 at the current exchange rate." Upon further investigation, counsel 9 10 for Oron has determined that that was an incorrect statement. The asset freeze order obtained by Plaintiff in Hong Kong was on "up to US\$3,000,000."
